A. Blue Cliff College

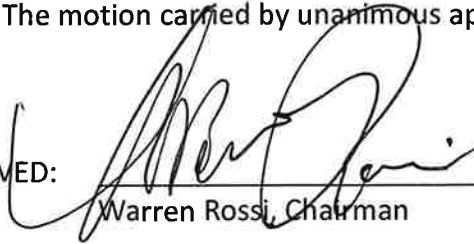
