Rules & Regulation: Mr. Edward Wiggins, AG/Attorney – Secretary of State, Board Members will review for approval at next board meeting.



Meeting adjourned, Motion approved by Clelly Farmer, 2nd by Lisa Watkins. Motion carried by all board members.






