4. Agreement between apprentice and sponsoring instructor;
5. If the sponsoring instructor is not the owner or manager of the sponsoring establishment, a signed and notarized letter of permission from the owner or manager for the requested apprenticeship to occur; and
6. Non-refundable \$50.00 application fee payable by check or money order.
