

# MISSISSIPPI STATE BOARD OF COSMETOLOGY AND BARBERING

# BOARD REQUIRED ESTABLISHMENT EQUIPMENT

## All Establishments must contain:

- 1. Signage that includes the business name and hours of operation;
- 2. Closed cabinet(s) of solid construction for clean towels;
- 3. Covered container(s) for soiled towels;
- 4. Lidded trash can(s) of solid construction;
- 5. An adequate supply of client drapes and linens (towels, sheets, and pillow covers); and
- 6. Sufficient supplies for giving complete services according to the establishment's license.

### Cosmetology Establishments must contain:

- 1. One (1) dresser or workstation with chair and mirror for each cosmetologist;
- 2. Adequate lighting for each working chair;
- 3. One (1) shampoo bowl and chair per every three (3) cosmetologists;
- 4. One (1) dryer. (A dryer is "a chair or standing hair dryer with a hood, either stationary or portable.");
- 5. Twelve (12) combs and six (6) brushes per cosmetologist;
- 6. One (1) wet sanitizer per cosmetologist and/or establishment;
- 7. One (1) soiled container (any clean, closed container) per cosmetologist; and
- 8. One (1) dry sanitizer (any clean, closed container) per cosmetologist.

# **Cosmetology Establishment with Wax Service** must contain, in addition to all requirements for Cosmetology Establishment:

- 1. One (1) free standing magnifying lamp;
- 2. One (1) lidded trash can with foot pedal of solid construction;
- 3. One (1) dry sanitizer; and
- 4. One (1) soiled container.

### Barbering Establishments must contain:

- 1. One (1) dresser or workstation with mirror for each barber;
- 2. Mirror of each workstation must be no less than 24x30 inches;
- 3. Hydraulic barber/styling chair for each barber:
- 4. Adequate lighting for each working chair;
- 5. One (1) shampoo bowl and chair per every three (3) barbers;
- 6. Twelve (12) combs and six (6) brushes per barber;
- 7. One (1) wet sanitizer per barber and/or establishment;
- 8. One (1) soiled container (any clean, closed container) per barber; and
- 9. One (1) dry sanitizer (any clean, closed container) per barber.

# Nail Technology Establishments must contain:

- 1. One (1) manicure table with lamp per nail technician;
- 2. One (1) patron chair and manicure stool per nail technician;
- 3. One (1) wet sanitizer (cotton and alcohol) per nail technician;
- 4. One (1) finger bowl per nail technician;

- 5. One (1) dry sanitizer (any clean, closed container) for clean implements per nail technician; and
- 6. Closed cabinet of solid construction for nail technology supplies per establishment.

## **Esthetics Establishments** must maintain the following:

- 1. Treatment area(s) located so as to ensure the privacy of the esthetics client;
- 2. One (1) treatment table/chair/bed and one (1) practitioner stool per esthetician;
- 3. One (1) sink within no more than fifteen (15) feet from each esthetics treatment area;
- 4. One (1) covered container for soiled linens in each esthetics treatment area;
- 5. One (1) closed cabinet of solid construction for clean linens in each esthetics treatment area;
- 6. One (1) closed cabinet for esthetics supplies;
- 7. One (1) free standing magnifying light per esthetician;
- 8. One (1) woods lamp per two (2) estheticians;
- 9. One (1) wet sanitizer per esthetic treatment area;
- 10. One (1) soiled container (any clean, closed container) per esthetician;
- 11. One (1) dry sanitizer per esthetic treatment area; and
- 12. Lidded trash can of solid construction with a foot pedal for each esthetician.
